1		Sentencing/Fined and placed on probation for three years for allegedly repeatedly failing to implement a Risk Management Plan to be executed in the event of an accidental release of anhydrous ammonia
2	James Petro, Richard McGoey	Plea Agreement/Pleaded guilty to one count of allegedly negligently causing the release of asbestos into the ambient air
2	James S. Marshall	Plea Agreement/Pleaded guilty to alleged negligent endangerment under the Clean Air Act
2	Gunay Yakup	Plea Agreement/Pleaded guilty to allegedly illegally removing and disposing of large quantities of asbestos-containing materials
3	Filibuster Distillery LLC, Filibuster Barrels LLC, Sid Dilawri	Indictment/Indicted on 115 counts of allegedly violating the State Water Control Law for dumping over 40,000 gallons of industrial waste into a stream in Shenandoah County, Virginia

4	Andrew Walker	Plea Agreement/Pleaded guilty to allegedly illegally discharging industrial waste into the Jackson, Mississippi, Sewer System
5	Robert J. Massey	Plea Agreement/Pleaded guilty to a criminal charge of violating the Clean Water Act stemming from alleged discharges of landfill leachate totaling more than forty-seven million gallons into the Flint, Michigan, sanitary sewer system
5	Bonnie Dennee	Sentencing/Sentenced to five years in federal prison, followed by a three-year term of supervised release, for alleged conspiracy to store and transport hazardous waste without required permits and manifests
5	Andrew Ecklund	Sentencing/Sentenced to two years of probation and ordered to pay a \$2,500 fine for allegedly falsifying laboratory test results
5	Eric Jay Weckworth-Pineda	Plea Agreement/Pleaded guilty to one count of alleged negligent discharge of a pollutant
5	Tanner John Sik	Plea Agreement/Pleaded guilty to one count of alleged negligent discharge of a pollutant
6	James Tassin	Plea Agreement/Pleaded guilty to allegedly violating the Clean Water Act in connection with an oil spill in 2016
6	E.I. du Pont de Nemours and Co, Inc.	Indictment/Indicted for allegedly knowingly violating requirements of federal safety regulations and allegedly negligently releasing 24,000 pounds of methyl mercaptan
6	Patrick Huse	Indictment/Indicted for alleged criminal conduct related to oil extraction in the Gulf of Mexico
6	Brandon Wall	Indictment/Indicted for alleged criminal conduct related to oil extraction in the Gulf of Mexico
7	Wyatt Travnichek	Indictment/Indicted on a federal charge accusing Travnichek of alleged tampering with a public water system and one count of alleged reckless damage to a protected computer during unauthorized access
7	Russell McKeehan, Sr.	Sentencing/Sentenced to four years of probation for alleged storage of hazardous waste without a permit (including a six-month term of home confinement)
7	Aaron Rochester	Plea Agreement/Pleaded guilty to one count of alleged unlawful storage of hazardous waste and one count of transportation of hazardous waste

9	Beatriz Santillan	Sentencing/Sentenced to 70 days in prison and ordered to pay \$20,079 restitution for allegedly smuggling illegal pesticides
10	4 Brothers Dairy, Andrew Fitzgerald	Sentencing/Sentenced for alleged unlawful discharge of pollutant into a water of the United States, a misdemeanor violation of the Clean Water Act and ordered 4 Brothers to pay a \$95,000 fine and owner Fitzgerald to pay a \$35,000 fine
10	Tae Ryung Yoon, aka Thomas Yoon, Yoo Jim Management Company, Ltd, Mush Inn Corp.	Sentencing/Sentenced for alleged asbestos work violations under the Clean Air Act. Yoo Jim Management Company, Ltd. and Mush Inn Corporation sentenced to 3 years of probation and ordered to jointly and severally pay \$30,000 in restitution and a \$35,000 fine. Tae Ryung Yoon sentenced to a term of 2 years' probation and ordered to complete 100 hours of community service
10	PurEnvironment	Sentencing/Sentenced to a year of probation, ordered to pay a \$15,000 fine, and come into compliance with state and federal regulations for alleged crimes regarding the company's false claims that its products could provide "90+ day protection" against COVID-19
