Association of Air Pollution Control Agencies Holds 2017 Fall Business Meeting in Raleigh, North Carolina

State and Local Air Agencies Elect 2017 - 2018 Officers, Recognize Three Best Practice Award Winners, Welcome Senior Officials from U.S. EPA, White House

From September 20 to 22, the Association of Air Pollution Control Agencies (AAPCA) held its 2017 Fall Business Meeting in Raleigh, North Carolina. More than 150 Clean Air Act practitioners, including senior officials from roughly 30 state and local air agencies, participated. The meeting included presentations on Clean Air Act topics from state and local air agencies, as well as senior officials from the White House Council on Environmental Quality and the U.S. Environmental Protection Agency's (EPA) Offices of the Administrator, Policy, Air and Radiation, Enforcement and Compliance Assurance, Research and Development, and several regional offices.

During the meeting, AAPCA's Board of Directors, which includes senior air officials from twenty state environmental agencies, elected its 2017-2018 Officers:

- **President: Stuart Spencer, Arkansas Department of Environmental Quality**
- **Vice President: Nancy Vehr, Wyoming Department of Environmental Quality**
- **Secretary/Treasurer: Vivian Aucoin, Louisiana Department of Environmental Quality**
- **Past President: Sean Alteri, Kentucky Division for Air Quality**

Following review by AAPCA's Best Practices Committee and Board of Directors, the Association recognized three member agencies with 2017 Best Practice Awards for ground breaking technology, innovative practices, or exemplary operations in the field of air pollution control:

- **National Ambient Air Quality Standards (NAAQS) Exceedance Reports-** Georgia Environmental Protection Division, Air Protection Branch (presented by Dr. Byeong-Uk Kim and Dr. James Boylan, Planning and Support Program)
- **Pollutants of Concern Table Implementation-** Kentucky Division for Air Quality (presented by Benjamin Matar, Permit Review Branch)
- **Standardization of an Engineer's Notebook for Title V Permitting-** Wyoming Department of Environmental Quality, Air Quality Division (presented by Lori Bocchino, Title V Program)

I was particularly pleased at the robust participation from U.S. EPA, including senior representatives from the Agency's regional offices, at this meeting." "I am proud of the great strides and leadership provided by the Association's eleven technical committees over the last year. AAPCA has found opportunities to provide meaningful, consensus comments on issues from addressing interstate and international air quality to regulatory reform to preparing for personal air sensors," reflected Past President Sean Alteri of the Kentucky Division for Air Quality.
