AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Premiere Plastics, Inc., Respondent, in the above captioned cause and agree as follows:

1.

By letter dated April 16, 2020, Respondent was contacted by Complainant and notified of the following violations at its facility located at 109 North Ford Street, Pontotoc, Mississippi in Pontotoc County:

- A. Air-Title V Operating Permit No. 2300-00024 Section 4.2: Respondent failed to submit a certification of compliance by January 31, 2020 for the 2019 calendar year.
- B. Air-Title V Operating Permit No. 2300-00024 Section 5.C.2: Respondent failed to submit a semiannual report by January 31, 2020 for the second half of the 2019 calendar year.

Complainant received the semiannual report on March 17, 2020 and the certification of compliance on April 2, 2020.

In lieu of a formal enforcement hearing concerning the violations listed above, Complainant and Respondent agree to settle this matter as follows:

A. Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$5,170.00. Respondent shall pay this penalty to MDEQ within sixty (60) days after this Agreed Order has been executed by the MDEQ Executive Director or his designee. The settlement payment shall be submitted to:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing before the Commission pursuant to Miss. Code Ann. § 49-17-31, and that it has made an informed waiver of that right.
